1) VIOLATION OF INTERNATIONAL LAW (UN Charter, and other international law instruments)

- a) UN General Assembly and UN Security Council decisions on Iraq and examination of these decisions
- b) Reports submitted by UN inspectors
- Violations of IHL, the 1948 Anti-Genocide Convention; Human Rights Declaration; the Geneva Conventions and their additional protocolls; other conventions and pacts

2) CONCEPTS OF LEGALITY AND LEGITIMACY IN INTERNATIONAL LAW AND THEIR EVALUATION IN THE CONTEXT OF THE OPERATION AGAINST IRAQ

- Evaluation of those articles of the UN Charter concerning use of force and prohibiting use of force.
- b) Evaluation of anti-war meetings and demonstrations in various countries, surveys concerning a potential attack against Iraq in the context of "legitimacy".
- c) Evaluation of statements and speeches made by the authorities of the attacking powers and their mouthpieces in the press..

3) EVALUATION OF THE "PRE-EMPTIVE" WAR DOCTRINE PROMOTED BY THE US AND ITS ALLIES

- a) What is the pre-emptive war doctrine? Who has created it?
- b) Its validity in the context of international law.

- b) War crimes
 What are the crimes that have been
 committed during the war? Killing and
 wounding civilian, attacking, bombing
 civilian targets, arresting civilians, treatment
 of war prisoners, evaluation in terms of
 Geneva Treaty, use of banned, illegal
 weapons, affects of these weapons on
 civilians. Has depleted uranium been used?
 Cluster bombs? Their effects..
- c) Crimes against humanity
 Intentional destruction of a whole country's infrastructure; effects of the embargoe;
 Looting and destruction of Iraqi and world cultural and historical heritage.
- d) Crime of genocide intentional use of the sanctions to kill large groups of civilians, mainly children; use of dangerous and illegal weapons which kill over generations, such as uranium (DU)
- e) Crimes against nature

 The destructive short and/or long term effects of the weapons used on nature and environment. Has a region been rendered uninhabitable? How large a region? For how long?
- f) Crimes against the future of the world and future generations

CONCERNING HEADLINE (1)

Views of and reports by international law experts from various countries, evaluation of reports submitted by UN inspectors, asking UN inspectors to state their views and evaluations.

CONCERNING HEADLINE (2)

Compiling information and documents on the legitimacy of the attack from various countries.
